

#### PRIVACY POLICY

## Last updated December 13, 2022

This **Privacy Policy** describes the personal information CleanRobotics Technologies, Inc. ("**CleanRobotics**", "we", "our", or "us") collects when you use the CleanRobotics website at https://cleanrobotics.com/ (the "**Website**"), how we use this information, with whom we share it, and the choices you have in connection with this.

### 1. INFORMATION WE COLLECT AND USE

Through your use of the Website, CleanRobotics will collect personal information, which is information that identifies you directly or indirectly as outlined below.

#### A. Information Collected From You

As you use the Website, CleanRobotics will collect personal information when you:

<u>Contact Sales/Ready to Learn More:</u> When you contact us with a question or inquiry through our "Contact Sales" or "ready learn more" forms, we collect, from you, your *identifiers* (name, company name, email address, phone number) and any other information you choose to include in your correspondence. We use this personal information to respond to your questions or inquiries, troubleshoot where necessary, address any topics you inquire about, and send you marketing emails. You may opt-out of receiving marketing emails from us by clicking the "unsubscribe" link provided with each email. Please note that we will continue to send you notifications necessary to the Website, or requested products or services.

CleanRobotics may also use your personal information collected for the above purposes to efficiently maintain our business, to comply with the law, and for other limited circumstances as described in **HOW WE SHARE YOUR INFORMATION**.

# **B.** Information Collected Automatically

In addition to the personal information you provide, when you use our Website, CleanRobotics automatically collects information via cookies and similar technologies. This information includes your:

- <u>Usage information</u>. This includes information such as: your time of visit to the Website, pages visited, search terms, actions taken, how much time you spend on each page, or customer objects throughout the Website and frequency of access. We use this personal information to: (i) conduct analytics; (ii) enhance user experience; (iii) prevent fraudulent use of the Website; and (iv) diagnose and repair errors.
- **Error information**. In the event of technical errors with the Website, we collect information in connection with an error message, including the filename, error line number, and any

related error message generated by the component that failed. We use this information to diagnose and repair errors.

- <u>Device information</u>. This includes information about the device you use to access our Website, such as browser type, browser language, hardware model, operating system, and your preferences. We use this personal information to: (i) conduct analytics; (ii) enhance user experience; (iii) prevent fraudulent use of the Website; (iv) diagnose and repair errors; (v) remember your preferences; and (vi) provide enhanced functionality.
- Google Analytics. For the Website, we use Google Analytics to collect information on your use of the Website to improve our Website. In order to collect this information, Google Analytics may set cookies on your browser, or read cookies that are already there. Google Analytics may also receive information about you from applications you have downloaded that partner with Google. We do not combine the information collected through the use of Google Analytics with personally identifiable information. Google's ability to use and share information collected by Google Analytics about your visits to our Website or to another application which partners with Google is governed by the Google Analytics Terms of Use and the Google Privacy Policy, available for review here. To prevent your data from being used by Google Analytics, you can download the Google Analytics opt-out browser add-on for Google Analytics which can be found here.
- Google Ads. We use Google Ads to deliver advertisements to you and to track whether you have interacted with an advertisement we have placed elsewhere on the internet. Google Ads stores a conversion tracking cookie on your device when you click on our advertisement. The information obtained through the cookie is used to generate statistics and allows us to see the total number of users who clicked on our advertisements. We also use Google Ads to present to users of our Websites advertisements across the internet and within the Google advertising network based on their visits to our Websites. - HubSpot. We use HubSpot to analyze the data traffic on our Website and your behavior while using our Website. We use this information to gain valuable insights into user behavior on our Website to improve our Website. For more information on Hubspot, please review its privacy policy. We also use Hubspot to send our emails and to track the behavior of our email recipients. With the help of Hubspot's conversion tracking, we can analyze whether a predefined action took place by an email recipient, such as opening our email, in order to better adapt and distribute our emails. In general, to disable cookies and limit the collection and use of information through them, you can set your browser to refuse cookies or indicate when a cookie is being sent.

### 2. HOW WE SHARE YOUR INFORMATION

## A. General Sharing

CleanRobotics may share the personal information identified in this Privacy Policy in the following instances:

- Within CleanRobotics: Where necessary, CleanRobotics will share your personal information within CleanRobotics in order to efficiently carry out business and to the extent permitted by law.
- <u>With service providers:</u> CleanRobotics will share your personal information with service providers that perform services on CleanRobotics's behalf. These service providers include our IT support and security, website hosting provider, and email provider.
- In the event of a corporate reorganization: In the event that CleanRobotics enters into, or intends to enter into, a transaction that alters the structure of CleanRobotics, such as a reorganization, merger, acquisition, sale, joint venture, assignment, consolidation, transfer, change of control, or other disposition of all or any portion of our assets, CleanRobotics would share your personal information with third parties, including the buyer or target (and their agents and advisors) for the purpose of facilitating and completing the transaction.
- For legal purposes: CleanRobotics will share your personal information where legally required, in response to court orders, law enforcement or legal process, including for national security purposes; to establish, protect, or exercise our legal rights, as required to contracts; to defend against legal claims or demands; to detect, investigate, prevent, or take action against illegal activities, fraud, or situations involving potential threats to the rights, property, or personal safety of any person; or to comply with the requirements of any applicable law.

#### 3. DO NOT TRACK

We do not support Do Not Track (DNT). Do Not Track is a preference you can set in your web browser to inform websites that you do not want to be tracked.

#### 4. INFORMATION SECURITY

CleanRobotics implements and maintains reasonable security measures, including access controls, to help protect the personal information that CleanRobotics collects and maintains. However, unfortunately, we cannot guarantee that our security measures will prevent malicious attacks to our systems 100% of the time.

## **5. AGE RESTRICTION**

The Website is not intended for individuals under the age of eighteen (18).
